Big SIR Phil VanSwoll called the meeting to order at 10:05 am. He asked if there were any additions or deletions to the agenda. Eddie Toews wanted an addition to the agenda to consider his request for more outings for the RV Club. The amended agenda was approved.

Secretary Bill Burnes took attendance and informed the board that a quorum was present.

**Secretary's Report** – The minutes of March 8, 2022 were approved as presented.

**Treasurer's Reports** – Treasurer Eddie Toews presented the March 2022 Treasurer's Report. He reported that we had an ending checking account balance for March 2022 of \$18,078.66 and \$300.00 cash on hand. There were General Fund receipts during March of \$1,043.00 and disbursements of \$413.21. There were Custodial Fund receipts of \$2,258.00 and Custodial Fund disbursements of \$1,175.00. The report was accepted as presented. He read off the names of members who have not yet paid their dues, and asked BEC members to contact any of these individuals that they know.

## **Expenditures:**

- 1. A motion was made by Eddie Toews and seconded by George Cocores to have Branch 136 pay for the lunch for the State President and his wife who will attend the Ladies Lunch in May. Also to pay for roses for his wife.
- 2. A motion was made by Marty Martin and seconded by George Cocores to purchase a wireless microphone for \$135.
- 3. A motion was made by Jim Botto and seconded by George Cocores to bring back the free birthday lunch by returning the \$19 he had paid for lunch.
- 4. A motion was made by Eddie Toews and seconded by Bill Burnes to have Branch 136 donate \$500 to the SIRS Foundation.
- 5. A motion was made by Bill Burnes and seconded by Marty Martin to spend \$150 for flowers for the Ladies Lunch.
- 6. A motion was made by Gene Bettencourt and seconded by Eddie Toews to spend up to an additional \$150 for the Ladies Lunch. The Ladies Lunch committee will decide what to spend the money on.

All of these motions were approved by the BEC.

Attendance/Membership Reports – George Cocores presented a Membership Report and Form 27 Monthly Review Report for February. We started March with 166 members, added 2 new members, and lost 3 members. We ended March with 165 members. The report was approved. There is a discrepancy of one member between this report and Form 27. This will be checked out and straightened out.

**Big SIR Report** – Phil VanSwoll acknowledged the passing on March 27 of John Bristow, a former Big SIR. There will be a celebration of his life on May 14 from 1PM to 3PM at the Church of the 49ers. If you plan to attend, bring an appetizer or dessert.
