Call to Order – Past Big SIR Eddie Toews called the meeting to order at 10:10 am.

**Roll Call** – Secretary Steven Holt took attendance and informed the board that a quorum was present.

**Approval of Agenda** – Big SIR Eddie Toews asked if there were any additions or deletions to the agenda. No additions, deletions or changes required for this meeting.

**Secretary's Report** – A hard copy of November minutes missing from this meeting. Big SIR Eddie Toews asked if everyone present had reviewed November's minutes. The group replied yes. Eddie then asked if there were any additions or corrections to November 14, 2023 meeting minutes. There were none and the minutes were approved as presented.

**Treasurer's Report** – Treasurer John Salmon provided the following financial report for November and December 2023.

In November, he reported a beginning checking account balance of \$15,232.02 and ending checking balance of \$17,399.08 with \$150.00 cash on hand. Luncheon profit \$188.00, Dues collected \$180.00, Bulletin ads for \$375.00, with a five-dollar overpayment, Christmas ticket sales \$2,400.00. Custodial Fund Receipts: Luncheon \$1232.00, New member badge \$24.00. General Fund Disbursements: Printing, Supplies and Taxes \$00, Postage \$00, Raffle expense \$42.00, Guest expense \$17.00, Award Frames \$33.74, Secretary supplies \$43.76, Rent, Setup, Cleanup \$300.00, Birthday lunch \$20.00, Sponsor lunch \$40.00. New Raffle tickets \$21.44, and \$500 cash withdrawal for Christmas. There were no additions or corrections to November financial presentation, thus the report was approved as presented.

For December's Christmas luncheon, checking account balance of \$17,399.08 and an ending checking balance of \$13,556.00 for December. Bulletin ads for \$375.00, Raffle ticket sales \$710.00, Christmas ticket sales \$480.00. Custodial Fund Receipts: General

Fund Disbursements: Printing, Supplies and Taxes \$226.27, Postage \$22.05, Award Frames \$145.56, Rent, Setup, Cleanup \$300.00, Birthday lunch \$20.00. Christmas luncheon expenses – Catering - \$3960.00, Table linens – \$393.49, Flowers - \$35.97, Wine - \$280.00, Member badges - \$15.12. There were no additions or corrections to December financial presentation, thus the report was approved as presented.

# **Big SIR Report** – Eddie Toews

- 1. Vision 2024 tabled for this meeting in Rick Bronner absents.
- 2. "Giving Back" This was explained as an unseen benefit for Branch #136 membership where 90% of the money collected is given back in the way of raffle prizes, paying for functions, fees or expenses for this organization. It is estimated that for 2023, a total of \$4,000.00 was given back to the branch. At February's meeting, the exact figures will be provided by Eddie as he didn't have the documentation available for January's meeting.
- 3. For 2024, a committee has been assembly (George Cocores, Eddie Toews, Gene Zanoni, Stan Enos) to work on the three major events held during the year. This includes the Mother's Day Luncheon, August Picnic, and Christmas Luncheon.

  One comment mentioned is the committee will work on a revised menu for the picnic in hopes of reducing cost to a level that will allow this event to be free to Branch #136 membership.
- 4. Subsidized meals for the BEC has been tabled until Rick Bronner's return.
- 5. Marketing progress Recruiting flyers printed, with holders, have been placed at the Senior Center and Area 12 on Aging. Looking for additional places to put flyers.
- 6. Looking for two BEC volunteers to go table-to-table looking for members to volunteer for the upcoming year.
